

To the Honorable, the Common Council, San Diego, California.

GENTLEMEN:

The undersigned respectfully petition as follows:

We, being residents and property owners in the vicinity of First Street and Arbor Drive, in the City of San Diego, hereby inform you that certain persons have lately begun the business of keeping horses for hire at the premises known as number 4237 First Street in San Diego; and that such business is now being carried on at said place; that a stable is maintained there in which a large number of horses are kept; that this place is a detriment to the neighborhood, that manure and refuse accumulate at and about the said stable, that flies and other insects are drawn thereto; and that offensive odors arise therefrom; that the place is a source of injury and of danger to the health of the residents nearby; that this place constitutes a nuisance and that it is detrimental to the progress and the welfare of this locality.

We therefore request that such action be taken by you as is needed for the suppression of this business.

We would inform you also that this place is within a block of the County Hospital, that it is near to the Vauclain Home (Tuberculosis Hospital) and to a Home for Children (adjoining the Vauclain Home).
