GENTLEMEN:

The undersigned respectfully petition as follows:

Mr. F. W. Robinson has under lease at the present time a two-story barn and basement located on East First Street on property legally described as Lots 10, 11 and 12 in Block 1, a portion of Block 3 and Lots 3 and 4 in Block 2 of First Street Addition, City of San Diego. He has been occupying this property for about thirty days, housing eight horses and does not intend to keep more than ten horses in the barn at any one time.

The yard and building have been kept in a cleanly manner, the manure being removed each day from the premises and it is his intention to have built at once a tin-lined air tight box in which the manure is to be placed.
