At night the whole air is permeated with the smell from this place, and in the day-time it is an eye-sore on account of wagons and other junk that have been in the streets for months. Inasmuch as there is an ordinance against maintaining dairies and other institutions of a like nature within the city limits we petition your honorable body to find some way to abate this nuisance, which is worse in every respect than a dairy possibly could be. Several times this has been brought to the notice of the Health Department and they would clean up, but in a day or two it would be the same old thing.
